



# DUE DILIGENCE – be proactive and be prepared!

### Why Safe Sanctuaries?

- 1. Protect our children, youth and vulnerable adults
- 2. Protect our staff and volunteers
- 3. Protect our church's resources/ assets for mission and ministry

#### The Facts

- Happens anywhere, in any neighborhood, religion or church group, racial or ethnic groups, and among the rich, the poor and everywhere in between.
- 1 in 3 girls and 1 in 5 boys are sexually abused before the age of 18.
- More than 90% of sexual abuse is committed by someone the victim knows, loves or trusts.
- A typical pedophile will commit 117 sex crimes in their lifetime.
- Abusers can be anyone: family members, neighbors, friends, doctors, coaches, youth leaders or clergy members.
- 30% of sexual abuse is never reported.
- Most sexual abuse happens to children between the ages of 12 and 17.
- 1 in 5 children are solicited sexually while on the Internet before the age of 18.
- More than 90% of vulnerable adults with developmental disabilities will be sexually abused at some point in their lives.

#### General Rules of Safer Sanctuaries

- 1. Criminal Background Check
- 2. The two-deep rule
- 3. Adults must be unrelated
- 4. Appropriate ratio of adults to vulnerable people maintained
- 5. Open sight and sound lines
- 6. The five year older rule
- 7. Up to date release forms
- 8. Separate shower and bathroom facilities
- 9. Separate sleeping quarters
- 10. Personal space without shared beds

# The Specifics – 5 Simple Rules

- 1. Listen to kids
- 2. Healthy touch and consent
- 3. Check-in and Check-out process in place
- 4. Off-site/traveling has same rules
- 5. Safety in numbers

# **Mandatory Reporting**

Determine is if the child, youth or vulnerable adult is in immediate danger.

If yes  $\rightarrow$  call 911

If no  $\rightarrow$  1-855-GA-CHILD (1-855-422-4453) An oral report should be made within 24 hours to Child Protective Services or appropriate law enforcement.

#### **DOCUMENT EVERYTHING!**

\*Church staff and volunteers are mandatory reporters.
